**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
APPROVING THE FIRST ADDENDUM TO THE AGREEMENT WITH BELLECCI &  
ASSOCIATES FOR THE 2016 PAVEMENT MAINTENANCE AND  
REHABILITATION/REPAIR PROJECT**

**WHEREAS**, on February 8, 2016, the City entered into an agreement with Bellecci & Associates for the technical analysis of the 2016 Pavement Maintenance and Rehabilitation/Repair Project in the amount of \$34,392; and

**WHEREAS**, the technical report has been completed and the City now desires to engage Bellecci & Associates to prepare the final contract bid documents for the 2016 Pavement Maintenance and Rehabilitation/Repair Project, including preparation of the project plans and specifications; and

**WHEREAS**, Bellecci & Associates provided the City with a proposal on June 3, 2016 in the amount of \$148,762 to complete the final design for the 2016 Pavement Maintenance and Rehabilitation/Repair Project; and

**WHEREAS**, staff has reviewed the proposal and recommends that the City Council approve the First Addendum to the Agreement with Bellecci & Associates in the amount of \$148,762 and authorize the City Manager to execute the First Addendum.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Millbrae hereby approves the First Addendum to the Agreement with Bellecci & Associates in the amount of \$148,762; and

**BE IT FURTHER RESOLVED** that the City Council of the City of Millbrae authorizes the City Manager to execute the First Addendum to the Agreement with Bellecci & Associates in the amount of \$148,762.
