

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
ESTABLISHING A PEOPLE-TO-PEOPLE COVENANT OF FRIENDSHIP, UNDER-  
STANDING AND RESPECT BETWEEN THE PEOPLE OF MILLBRAE, SAN MATEO  
COUNTY, STATE OF CALIFORNIA, UNITED STATES OF AMERICA, AND THE  
PEOPLE OF LA SERENA, PROVINCE OF COQUIMBO, CHILE, SOUTH AMERICA

WHEREAS, the People-to-People Program was established at the White House, Washington, D.C., United States of America for the purpose of creating greater friendship and understanding between the peoples of the United States and other Nations through the medium of direct personal contact, and which Program President John F. Kennedy of the United States of America heads as Honorary Chairman, and General Dwight D. Eisenhower as Chairman of the Board of Trustees, and

WHEREAS, to implement this program the Civic Committee of the People-to-People Program and the American Municipal Association in cooperation with the Office of Private Cooperation of the United States Information Agency have encouraged Millbrae and other cities in the United States to establish Town Affiliations with communities of other countries for the purpose of cultivating International understanding, and

WHEREAS, the people of Millbrae, California, desire to give expression of their admiration and friendship for the people of South American in general and for the people of Chile especially - and in particular for the people of LA SERENA, and

WHEREAS, the City of Millbrae, through its Council does recognize and endorse this Program with the hope of strengthening the Bonds of Friendship between our two great Nations and the Continents of South America and North American - and thus join in helping build the road to World Peace;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF MILLBRAE, CALIFORNIA, AS FOLLOWS:

Section 1. That the City of Millbrae, California and its People EXTEND AN INVITATION to the Government and the People of the City of La Serena, Chile, to participate with Millbrae as its SISTER CITY in the "People-to-People Program" for the purpose of creating a lasting friendship between our two communities.

Section 2. That this City Council does hereby proclaim that the People of Millbrae and its City Government send to the People and City Government of La Serena their felicitation as we join hands in cultivating love and respect for each other through our various cultural, educational, agricultural, industrial and commercial exchanges on a people-to-people level.

Section 3. That Mrs. Lewis S. Germain is hereby authorized to act as Official Representative of Millbrae, San Mateo County, California, U.S.A., to carry out this program.
