TO THE HONORABLE VICE MAYOR MAURICE GOODMAN: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of District 4, City of Millbrae, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of City Councilmember, in the city of Millbrae, California. The grounds for the recall are as follows: ignoring the concerns and wishes of the community, failure to protect Millbrae's fiscal sustainability, neglecting your fiduciary duties as an elected city officials, working with county chief executive without transparency and against the best interests of your constituents, undermining the fundamental trust of the community, as demonstrated by your actions with the La Quinta Inn project.
